<p>Deposit and Balance A deposit per person is required to secure a booking. This amount will be set out on the travel information brochure of your tour and is payable by cash only. FINAL PAYMENT: Is due 5 days before departure at Scuba Shack and is payable by cash only. Failure to comply may result in tour cancellation and forfeit of deposit. Variations to above may exist; it is client's responsibility to be aware of conditions applicable to the specific tour.</p> <p>Cancellation (a) Bookings cancelled by the traveler at any time after confirmation are subject to the forfeit of deposit, including any additional deposits required by suppliers. (b) In addition to this fee are any charges made by the hotel, tour operator, or other principal. This can amount to up to 100% of total arrangement costs, particularly when cancelling tours and other arrangements within 14 days of departure.</p> <p>Unused Services Due to weather, transport delays, strikes and other causes beyond the control of Scuba Shack, the tour may be cancelled Scuba Shack will make every Endeavour to secure refunds, but will not be held responsible for refunds not forthcoming. No refunds will be granted due to the traveler, deciding not to partake in the tour.</p> <p>Changes in Prices or Itineraries In this time of escalating prices and economic instability it is impossible to foreshadow accurately fluctuations in the cost of fuel, accommodation, and services in general. Scuba Shack reserves the right to adjust our prices as may be necessary at any time, up to and including the day of departure of tour. Although no changes to itineraries, hotels or dive locations are anticipated, Scuba Shack reserves the right to make such changes if necessary without notice.</p> <p>Underwater Activities Scuba Shack its servants, agents and employees do not assume any responsibility or liability for the safety of any participating individual in any activity offered by way of tour itinerary including but not by way of limitation, activities of scuba diving and snorkelling. Clients on all diving tours must be aware that the on-site dive operator has sole responsibility for diving activities and has the right to refuse diving to any individual without recompense for reasons of health including instability or suspect or real intoxication or the results thereof, or for any suspect or real inability or incompetence.</p> <p>Divers and Snorkellers Should take all equipment consistent with their activity including air tank and weights. Gear for hire is not always available at the destination so hire arrangements should be made prior leaving for your destination. Scuba divers should be qualified to recognized "Open Water" standard and be medically fit to participate in scuba diving activities. Proof of such may be requested by on-site dive operators. Qualifications should be carried. If in doubt as to qualifications or ability, discuss with staff at Scuba Shack.</p> <p>Hire Scuba Shack will hire any Scuba equipment to those on the tour. Conditions of hire form will be signed and payment will be made prior to taking any equipment from Scuba Shack.
